The Trumbull Police Pension Fund Board of Trustees meeting was called to order at 5:30 p.m.

Approval of May 17, 2022 Trumbull Police Pension Board Minutes

Motion made by Trustee Allen to approve the May 17, 2022 Special Police Pension Board minutes, seconded by Trustee Lombardo. There was no further discussion. Motion passed with three abstentions Trustees, Coppola, Thornton and Trefz.

Approval of March 16, 2022 Trumbull Police Pension Board Minutes

Motion made by Trustee Thornton to approve the March 16, 2022 Special Police Pension Board minutes, seconded by Trustee Coppola. There was no further discussion. Motion passed with two abstentions Trustees, Allen and Trefz.

Approval of March 8, 2022 Trumbull Police Pension Board Minutes

Motion made by Trustee Perez to approve the March 8, 2022 Special Police Pension Board minutes, seconded by Trustee Allen. There was no further discussion. Motion passed unanimously.

Correspondence

Trustee Coppola read letter from Union President Brian Federowicz to Chairman Baldwin notifying the Trumbull Police Pension Board of Trustee that the Trumbull Police Union voted on June 9, 2022. The three (3) elected members that have been re-elected to represent as trustees from July 1, 2022 to July 1, 2024 will be Lt. Donald Allen, Det. Sgt. Robert Coppola and Det. Edgar Perez.

Approval of Retiree Pension Adjustments – Escalator Increase – Effective July 1, 2022 to June 30, 2023

Chairman Baldwin indicated that the trustees received the spreadsheets with the calculations.

Trustee Coppola indicated that the escalator increase sheet has been reviewed along with Actuary Brad Fisher of USI. Trustee Coppola explained that any increases the Trumbull Police Union receives the retirees receive one-half of the increase as part of the contractual agreement.

Trustee Coppola asked if there were any questions he would be happy to answer. There were none.

Trustee Coppola made a motion to accept the approval of the retiree pension escalator increase effective July 1, 2022 to June 30, 2023, seconded by Trustee Allen. There was no further discussion. Motion passed unanimously.

There being no further business to discuss and upon motion made by Trustee Coppola and seconded by Trustee Perez the Trumbull Police Pension Board adjourned by unanimous consent at 5:35 p.m.
