



Clarifications and answers to some questions

Questions about the bid language in Section 3 alternate bid it seems to be contradictory. The explanation says the contractor is to remove the curbing but then later in the explanation it states the town will remove all curbing and excess material. The bid sheet also states the contractor is to remove curbing. Can you clarify?

The language in the bid document says the town will provide the equipment to remove curbing and dispose of it. Inevitably there will be very small pieces of curb that cannot be removed by machine such as under mailboxes, etc. They are usually removed by hand after reclamation has loosened them up. This is where the language comes in that the contractor is responsible for "hand removal of asphalt and curbing which cannot removed by machine". In other words the contractor is responsible for all the handwork in addition to the final grading and compaction of the roadway so it is ready for binder by the paving contractor.

Also would you consider changing the unit for disposal of material to cubic yards instead of square yard; this is not a typical way of measure for disposal.

As for changing the unit of measure for the disposal of material, the Town will accept the units for disposal from all bidders in **cubic yards** for section 3 but the bidder will have to include specifics on how the quantities will be verified. This option is mandatory for all contractors in the bid proposal to change out **Sq. Yd.** To **Cubic Yards** Please listed as such and crossed out and highlighted as such and to include specifics on how the quantities will be verified.

**Clarifications and answers to some questions**

Questions - Section 2 Base Bid Milling. Disposal of millings by the sy would be different in each category because of the sy involved. It would be easier to not have a separate item and just make it part of the milling price. Also, would the town take the material or does the contractor have to find a home for it?

Response - . In section 2 base bid, the square yard pricing in each category reflects the contractor providing all equipment necessary to mill, clean up and transport the material to a town designated dump site within town. At the Towns discretion, the Town may decide that they do not want or need the material generated during the milling process. The contractor will then be directed to dispose of the material. The "Disposal of material" price will then apply and should reflect the additional transportation, coordination and any disposal fees that the contractor expects to incur at a dump site the contractor is responsible for locating. The disposal is separated in an effort for the Town to realize savings if the material will be retained within and by the Town or Trumbull

Questions - Section #3 Base Bid category: The scope of work includes transporting. Can you define that? I'm thinking it's the trucking/removal of curbs, however, I want to be sure. Your Reclamation bid only addresses the depth of pavement, do you have any estimated quantities? (The milling portion of your bid has quantities of 0-2499 SY, 2500 to 7499 SY, etc.)

Response - Transportation is the trucking for all excess material generated during the curb removal, reclaiming and grading process that will need to be removed from the site and hauled to a town designated dump site within town. The Town may, at its discretion, direct the contractor to dispose of some or all of the excess material. The "Disposal of material" price will then apply and should reflect the additional transportation (trucking) costs along with any disposal fees the contractor expects to incur at a dump site the contractor is responsible for locating. As for quantities, they will be generated on an as needed basis. The Town will make every effort to group sites in close proximity to each other that will be done as a package.



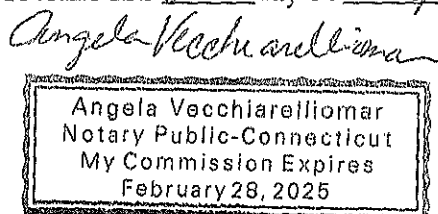
