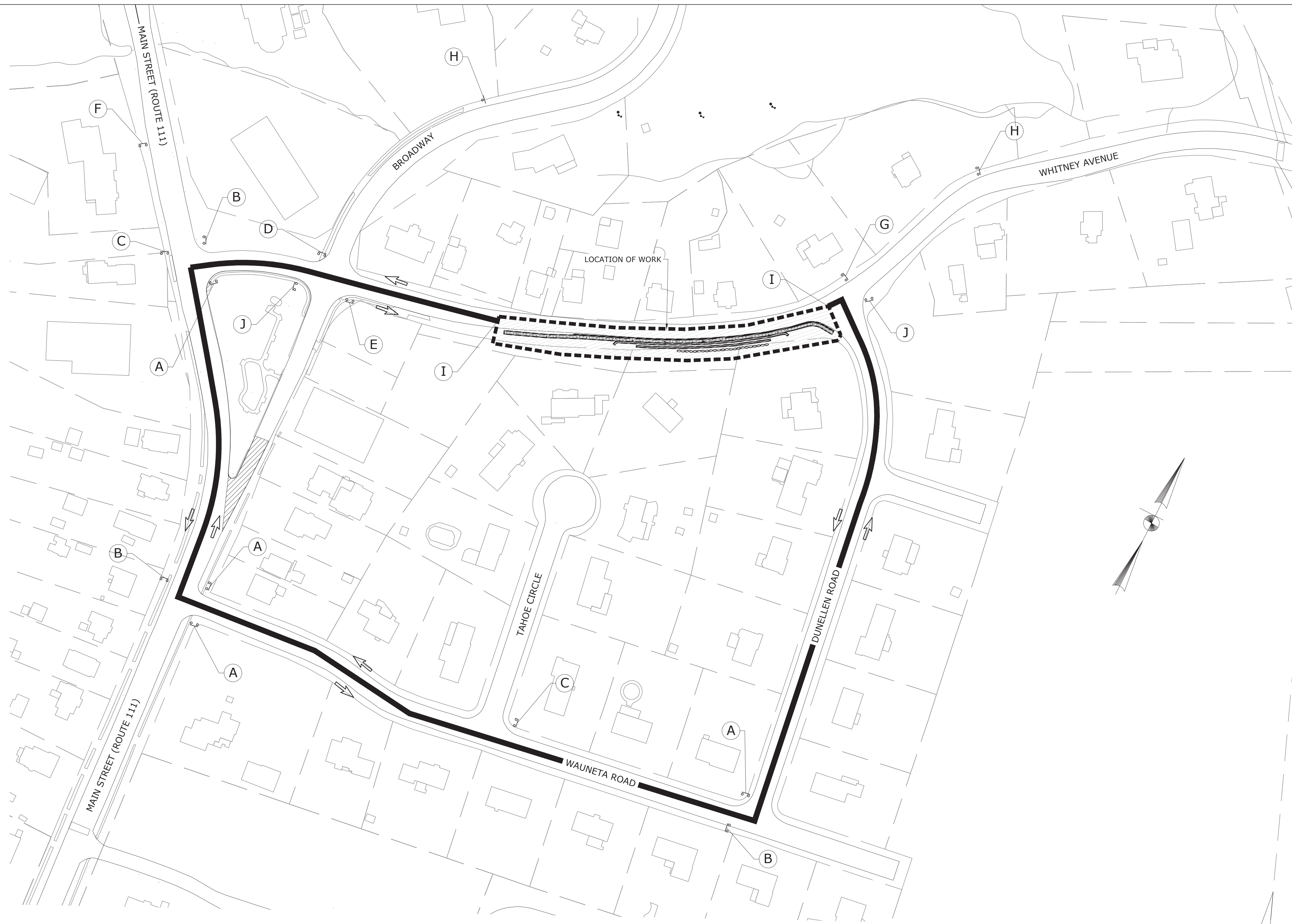

DETOUR NOTES:

- ALL SIGN LOCATIONS INDICATED ON THIS PLAN ARE APPROXIMATE. EXACT LOCATIONS OF SIGNS SHALL BE DETERMINED IN FIELD AS DIRECTED BY THE ENGINEER.
- DETOUR SIGNS SHALL BE COVERED WHEN THE DETOUR IS NOT IN OPERATION.
- DETOUR SIGNS SHALL BE REMOVED WHEN THE DETOUR IS NO LONGER REQUIRED.
- ALL CONSTRUCTION SIGNS ARE TO BE INSTALLED SUCH THAT THEY DO NOT BLOCK, OR ARE NOT BLOCKED BY, EXISTING SIGNS, AND DO NOT INTERFERE WITH SIGHT LINES.
- EXISTING SIGNS WHICH CONFLICT WITH THE DETOUR SIGNS SHALL BE COVERED WHILE THE DETOUR IS IN EFFECT, AS DIRECTED BY THE ENGINEER.
- BARRICADE WARNING LIGHTS - HIGH INTENSITY SHALL BE MOUNTED ON ALL DIAMOND SHAPED POST-MOUNTED CONSTRUCTION SIGNS AND SIGN (I).
- CONTRACTOR TO NOTIFY THE TOWN OF TRUMBULL EMERGENCY SERVICES TWO WEEKS PRIOR TO THE CLOSURE.
- THE COST OF DETOUR SIGNS SHALL BE PAID FOR UNDER THE ITEM "CONSTRUCTION SIGNS".
- RELOCATION OF TEMPORARY PRECAST CONCRETE BARRIER CURB FOR ACCESS TO WORK AREA SHALL NOT BE MEASURED FOR PAYMENT.
- MAINTAIN ACCESS TO ALL DRIVEWAYS DURING CONSTRUCTION.

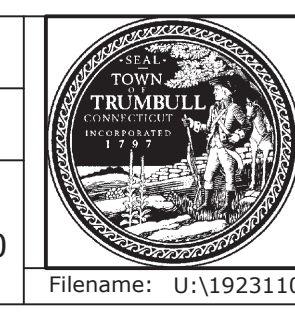
MAINTENANCE AND PROTECTION OF TRAFFIC PLAN
