1. RESOLUTION TC28-159: To consider and act upon a resolution which would appoint Abigail Whitmoyer of 30 Lansing Avenue as a member of the Trumbull Day Commission for a term extending to September 1, 2022. (Miller) (Finance)
2. RESOLUTION TC28-160: To consider and act upon a resolution which would appoint Jennifer Uriguen of 235 Tashua Road as a member of the Trumbull Day Commission for a term extending to September 1, 2024. (Lepore) (Finance)
3. RESOLUTION TC28-161: To consider and act upon a resolution which would approve the recommendation of the First Selectman and appoint Kathleen Champion of 39 Under Cliff Road as a member of the Police Commission for a term extending to the first Monday of December 2021. (Vazzano) (Finance)
4. RESOLUTION TC28-162: To consider and act upon a resolution which would declare the Town of Trumbull a Pollinator-Friendly Community and encourages and supports pollinator health and urges the community members to adopt pollinator-friendly practices. (L&A)
5. RESOLUTION TC28-163: To consider and act upon a resolution which would authorize the submission of a funding application for the Caregiver Services Grant, and identify Vicki A. ISSUE AND MAKING DETERMINATIONS WITH THE REFUNDING BONDS ANY OTHER AUTHORIZED BUT UNISSUED BONDS OF THE TOWN, AUTHORIZING AGREEMENTS FOR THE INVESTMENT OF REFUNDING ESCROW AND ITS REINVESTMENT OVER ITS TERM." (Finance)

7. RESOLUTION TC28-165: To consider and act upon a resolution which would approve a labor agreement between the Town of Trumbull and the Fire Marshal's Union Local 1303-277, Council 4, AFSCME, AFL-CIO July 1, 2020 through June 30, 2022 and would further approve the funding therefor. (L&A)
8. RESOLUTION TC28-166: To consider and act upon a resolution which would authorize the Town attorney to settle a workers compensation claim known as Brian Orkisz v. the Town of Trumbull. (L&A)
9. RESOLUTION TC28-167: To consider and act upon a resolution which would authorize the submission of the funding application to the LOTCIP program for the Spring Hill Road improvements and identify Vicki A. Tesoro, First Selectman as the individual authorized to sign the application and all subsequent amendments, reports and related documents in order to administer and implement the project. (L&A)
10. RESOLUTION TC28-168: To consider and act upon a resolution which would repeal and replace Chapter 19 of the Municipal Code (Utilities). (L&A) (Public Hearing Town Council April 5, 2021)
11. RESOLUTION TC28-169: To consider and act upon a resolution which would approve the transfer of ownership of 104 square feet of property at 366 Church Hill Road from the Town of Trumbull to the State of Connecticut for the maintenance of the culvert. (L&A)
12. RESOLUTION TC28-170: To consider and act upon a resolution which would amend Chapter IV, Sections 2D, 3A, and 3B of the Charter of the Town of Trumbull for the sole purpose of modifying its budget adoption dates pursuant to Section 7-191b of the Connecticut General Statutes. (L&A)
13. RESOLUTION TC28-171: To consider and act upon a resolution which would affirm the existence and importance of the EDIT Task Force and EDIT's Mission "to strengthen Trumbull's identity as a diverse, equitable, and inclusive community". Said resolution, to further assist the EDIT Task Force to accomplish its mission, requires that the EDIT Task Force shall not meet or conduct business until such time as it has its full complement of 8 members appointed by the Town Council and at which time the Town Council also will appoint a new Chairman and Vice Chairman. (L&A)
14. RESOLUTION TC28-172: To consider and act upon a resolution which would expand the Equity, Diversity and Inclusion Task Force to a nine (9) member body to include a member of the Trumbull Police Department and that such member be and the same is here by appointed. (L&A)
15. RESOLUTION TC28-173: To consider and act upon a resolution which would suspend its activities of the Equity, Diversity and Inclusion Task Force until such time as the Town Council reviews its charge, the Task force provides a quarterly report to the Town Council and a new Chairperson of the Task Force is selected. (L&A)
16. RESOLUTION TC28- 174: To consider and act upon a resolution whereby the TOWN COUNCIL of the TOWN OF TRUMBULL declares its opposition to SB 1024. (L&A)
