ARTICLE II- USE REGULATIONS

SECTION 1: SINGLE FAMILY RESIDENCE ZONES

1.1.2 Permitted Accessory Uses

Shed (Accessory Storage Buildings):

- a.** The use of a shed for storage accessory to a dwelling may be authorized by Certificate of Zoning Compliance, provided that the Zoning Enforcement Officer finds that the shed complies with the following terms, conditions and standards:
 - i.** The shed shall not contain more than 150 square feet of floor space for lots $\frac{1}{2}$ acre or smaller or 192 square feet of floor space for lots larger than $\frac{1}{2}$ acre, and shall not be a height greater than 10 feet;
 - ii.** The shed shall not be closer to the front lot line than the rear line of the dwelling upon said lot, and if not attached to the rear of said dwelling, shall not be less than 5 feet from both the rear and side lot lines for lots $\frac{1}{2}$ acre in size or smaller or 10 feet from both the rear and side lot lines of said lot for lots larger than $\frac{1}{2}$ acre;
 - iii.** The color and exterior design shall be such as to be in general harmony with the dwelling on said premises;
- b.** Temporary Storage Structures: Temporary Storage Structures in addition to those in the preceding paragraph may be authorized by Certificate of Zoning Compliance, provided that they shall be used for no more than three (3) months. The Certificate of Zoning Compliance may be renewed for up to an additional three (3) months. This provision shall not be invoked for any property more than once every ten (10) years.
