




**Description of 'Proposed Overlay Zone ALF' on land of 48 Monroe Turnpike,

Beginning at a point in the northerly street line of Old Mine Road, said point being the southwest corner of the 'Proposed Overlay Zone MFOZ' and the southeast corner of the within described Zone, thence the following courses and distances along Old Mine Road and Monroe Turnpike (CT Route 111), each in part: N70°-37'-21" W a distance of 206.46' to a point; thence deflecting to the right on the arc of a curve having a radius of 452.46' and a central angle of 18°-58'-16" a distance of 149.81' to a point; thence N04°-34'-51" E a distance of 108.85' to a point; thence deflecting to the right on the arc of a curve having a radius of 910.93' and a central angle of 14°-05'-58" a distance of 224.17' to a point; thence N30°-26'-35" E a distance of 288.30' to a point; said point being the northwest corner of the within described Zone: thence the following courses and distances along the 'Proposed Overlay Zone MFOZ': N76°-24'-40" E a distance of 195.28' to a point; thence S29°-21'-03" E a distance of 214.32' to a point; thence S00°-55'-59" W a distance of 136.05' to a point; thence S29°-21'-03" E a distance of 93.80' to a point; thence S15°-38'-57" W a distance of 69.80' to a point; thence S29°-21'-03" E a distance of 198.37' to a point; thence S51°-41'-38" W a distance of 129.72' to a point; thence S73°-43'-41" W a distance of 213.51' to the point and place of beginning.


EXISTING ZONES
