Homes are pre-cooled up to an hour before the event. To be eligible for the incentives, the thermostat needs to be connected to the HVAC system and be on cooling mode. Customers can opt out at any time.	No
UI Only Wi-Fi Thermostats	\$25 enrollment/ device, \$20 participation/ year	On peak electric demand periods, enrolled thermostats will be automatically adjusted to save energy, help the environment and improve the reliability of the electricity grid. At the start of an event, your thermostat will be automatically adjusted up to four degrees and will last approximately two hours. In addition, your thermostat may also be adjusted down two degrees prior to an event to pre-cool your home to minimize any impact on comfort. You can anticipate at least one event annually, and a maximum of up to six events per summer. To be eligible for the incentives, you must have installed a qualifying connected thermostat controlling your central air conditioning system. Customers can opt out of an event at any time.	No
