RESOLUTION TC30-85: To consider and act upon a resolution which would authorize the submission of the funding application for the Local Prevention Council Grant for the purpose of reducing vaping use rates among 12–18-year-olds, and identifies Vicki A. Tesoro, First Selectman, as the individual authorized to sign the application and all subsequent amendments, reports and related documents in order to administer and implement the project. (L&A)
