NOTICE IS HEREBY GIVEN that at a meeting of the Trumbull Town Council held on October 7, 2024, the following legislation was adopted:

1. RESOLUTION TC30-94: BE IT RESOLVED, That the sale of a portion of real property at 6175 Main Street is hereby approved, and that Vicki A. Tesoro, First Selectman, is hereby authorized to execute all documents required to finalize the sale.
2. RESOLUTION TC30-85: BE IT RESOLVED, That the Trumbull Town Council authorizes the submission of the funding application for the Local Prevention Council Grant for the purpose of reducing vaping rates among 12-18 year-olds, and identifies Vicki A. Tesoro, First Selectman, as the individual authorized to sign the application and all subsequent amendments, reports and related documents in order to administer and implement the project.
3. RESOLUTION TC30-86: BE IT RESOLVED, That Vicki A. Tesoro, First Selectman, is hereby authorized as the individual authorized to sign the grant application to the Connecticut Secretary of the State, and all subsequent contracts, amendments, reports and related documents in order to administer and implement the early voting program.
4. RESOLUTION TC30-87: BE IT RESOLVED, That the acceptance of funding in the amount of \$842,400 from CTDOT, LOTCIP for the Whitney Avenue Sidewalk-Phase II Trail Connection Improvements project, and identifies Vicki A. Tesoro, First Selectman, as the individual authorized to sign the application, agreement, and all subsequent amendments, reports and related documents in order to administer and implement the project.
5. RESOLUTION TC30-88: BE IT RESOLVED, That \$195,171 is hereby appropriated from the Fund Balance to various accounts.
6. RESOLUTION TC30-89: BE IT RESOLVED, That \$120,523 is hereby transferred from Contingency to various accounts.
7. RESOLUTION TC30-90: BE IT RESOLVED, That \$39,266 is hereby appropriated from the Fund Balance to 01030200-578802 Mntnce/Rep-Equipment/Building.
8. RESOLUTION TC30-91: BE IT RESOLVED, That the funding for the tentative agreement between the Town of Trumbull and the International Union of Operating Engineers, Local 30 Trumbull (Non-Supervisory) Highway & Parks Employees Union. Beginning July 1, 2022 to June 30, 2025 is hereby approved.
9. RESOLUTION TC30-92: BE IT RESOLVED, That the Town Attorney is hereby authorized to settle a certain Tax Appeal matter known as Trumbull Shopping Center #2, LLC v. The Town of Trumbull, Docket No. HHB-CV-22-6073382-S.
