8. RESOLUTION TC30-131: BE IT RESOLVED, That \$425,000 is hereby appropriated from the General Fund to 01013400-511152 Employee Benefits – Fringe – Workers Comp.
9. RESOLUTION TC30-132: BE IT RESOLVED, That \$175,000 is hereby appropriated from the General Fund to 01080800-578806 Tree Warden – Emergency Services.
