1. RESOLUTION TC30-133: To consider and act upon a resolution which would authorize Vicki A. Tesoro, First Selectman, to accept \$49,038.00 of incentives from the Municipal Energy Opportunities Program for the Trumbull Police Department Retro-fit Project and authorizes Vicki A. Tesoro, First Selectman to sign the agreement and all subsequent documents in order to administer and implement the project. (L&A)
 2. RESOLUTION TC30-134: To consider and act upon a resolution which would approve TSKP Studio, LLC as the architect for the Hillcrest Middle School Replacement project as recommended by the Hillcrest Middle School Building Committee. (L&A)
 3. RESOLUTION TC30-135: To consider and act upon a resolution which would repeal and replace Chapter 18, Article IV of the Municipal Code. (L&A) (Public Hearing Town Council April 7, 2025)
 4. RESOLUTION TC30-136: To consider and act upon a resolution whereas the Town of Trumbull hereby grants an easement to the State of Connecticut Department of Transportation in accordance with the map dated October 2024 detailing the proposed easement, for consideration of \$500.00; and authorizes First Selectman Vicki A. Tesoro to execute the Acceptance Agreement and all subsequent documents required to effectuate the transfer. (L&A)
 5. RESOLUTION TC30-137: To consider and act upon a resolution which would amend the motor vehicle tax depreciation schedule, commencing with the 2024 Grand List. (L&A)
 6. RESOLUTION TC30-138: RESOLUTION APPROPRIATING \$31,750,000 FOR THE PLANNING, DESIGN, DEMOLITION, CONSTRUCTION, RENOVATION, EQUIPPING AND FURNISHING OF A NEW SENIOR CENTER AND AUTHORIZING THE ISSUANCE OF \$31,750,000 BONDS OF THE TOWN TO MEET SAID APPROPRIATION AND PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE (Finance)
 7. RESOLUTION TC30-139: To consider and act upon a resolution whereas the resolution entitled "Resolution Appropriating \$31,750,000 For The Planning, Design, Demolition, Construction, Renovation, Equipping And Furnishing Of A New Senior Center And Authorizing The Issuance Of \$31,750,000 Bonds Of The Town To Meet Said Appropriation And Pending The Issuance Thereof The Making Of Temporary Borrowings For Such Purpose", adopted by the Town Council on April 7, 2025, be submitted to the Town electors for approval or disapproval at a referendum to be held on Tuesday, June 17, 2025, between the hours of 6:00 a.m. and 8:00 p.m. (E.T.), and that the warning of said referendum shall state the question to be voted upon. 8. RESOLUTION TC30-140: To consider and act upon a resolution which would direct the Town Clerk of Trumbull to prepare explanatory text for the Senior Center Referendum question, with the approval of the Town Attorney in consultation with the bond counsel and the Council Chairman. (Finance)
