NOTICE IS HEREBY GIVEN That the Town Council of the Town of Trumbull will hold a meeting on June 2, 2025, at the Trumbull Town Hall, at 7:30 p.m. with respect to the following proposed resolutions:

1. RESOLUTION TC30-144: To consider and act upon a resolution which would designate _____ as a District 7 Democrat Town Council representative for a term extending to the first Monday of December 2025. (Shively)
2. RESOLUTION TC30-145: To consider and act upon a resolution which would appoint _____ as a Town Council representative to the Trumbull Veterans & First Responders Center Building Committee. (L&A)
3. RESOLUTION TC30-146: To consider and act upon a resolution which would authorize the application to the State of Connecticut Department of Revenue Services (DRS) for the Neighborhood Assistance Act program to include the Make A Wish Foundation of CT (\$32,500), Mutual Housing Association of Southwestern CT (\$126,000), Saint Vincent's Medical Center (\$150,000), and Aspire Living and Learning (\$40,000) and that would authorize First Selectman Vicki A. Tesoro, or her designee, to submit such application and sign all related forms, contracts, and reports in order to implement the Neighborhood Assistance Act program. 6. RESOLUTION TC30-149: To consider and act upon a resolution which would approve Bismark Construction as the construction manager for the Hillcrest Middle School Replacement project as recommended by the Hillcrest Middle School Building Committee. (L&A)
7. RESOLUTION TC30-150: To consider and act upon a resolution which would approve Arcadis U.S., Inc. as the Owner's Project Manager for the Hillcrest Middle School Replacement project as recommended by the Hillcrest Middle School Building Committee. (L&A)
8. RESOLUTION TC30-138: RESOLUTION APPROPRIATING \$31,750,000 FOR THE PLANNING, DESIGN, DEMOLITION, CONSTRUCTION, RENOVATION, EQUIPPING AND FURNISHING OF A NEW SENIOR/COMMUNITY CENTER AND AUTHORIZING THE ISSUANCE OF \$31,750,000 BONDS OF THE TOWN TO MEET SAID APPROPRIATION AND PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE (L&A)
9. RESOLUTION TC30-139: To consider and act upon a resolution whereas the resolution entitled "Resolution Appropriating \$31,750,000 For The Planning, Design, Demolition, Construction, Renovation, Equipping And Furnishing Of A New Senior Center And Authorizing The Issuance Of \$31,750,000 Bonds Of The Town To Meet Said Appropriation And Pending The Issuance Thereof The Making Of Temporary Borrowings For Such Purpose", adopted by the Town Council on April 7, 2025, be submitted to the Town electors for approval or disapproval at a referendum to be held on Tuesday, June 17, 2025, between the hours of 6:00 a.m. and 8:00 p.m. (E.T.), and that the warning of said referendum shall state the question to be voted upon. 10. RESOLUTION TC30-140: To consider and act upon a resolution which would direct the Town Clerk of Trumbull to prepare explanatory text for the Senior Center Referendum question, with the approval of the Town Attorney in consultation with the bond counsel and the Council Chairman. (L&A)
