NOTICE IS HEREBY GIVEN that the Town Council of the Town of Trumbull will hold a meeting in the Council Chambers in the Town Hall on July 10, 2025, at 7:30 P.M. (E.T.), with respect to the following proposed resolutions:

1. RESOLUTION TC30-145: To consider and act upon a resolution which would appoint _____ as a Town Council representative to the Trumbull Veterans & First Responders Center Building Committee. (Finance)
2. RESOLUTION TC30-151: To consider and act upon a resolution which would appoint Samantha Miller as a member of the Equity, Diversity and Inclusion Task Force for a term extending to the first Monday of December 2028. (Pacelli) (Finance)
3. RESOLUTION TC30-152: To consider and act upon a resolution which would authorize Vicki A. Tesoro, First Selectman, to apply to the Connecticut Department of Transportation Microgrant Program for funding in the amount of \$5,000 for the purchase of eight bicycle racks and to sign all subsequent contracts, amendments, reports and related documents in order to administer and implement the project. 4. RESOLUTION TC30-153: To consider and act upon a resolution which would authorize Vicki A. Tesoro, First Selectman and Michael Lombardo, Chief of Police to file an application to the Department of Justice, Community Oriented Policing Services, School Violence Prevention Program for funding to improve school safety and security, and to sign all subsequent contracts, amendments, reports and related documents to administer and implement the project. 6. RESOLUTION TC30-155: To consider and act upon a resolution which would approve the funding for a labor agreement between the Town of Trumbull and IAEP Local R1-604, SEIU, NAGE (EMTs and Paramedics) beginning July 1, 2024, and ending June 30, 2027. (L&A)
7. RESOLUTION TC30-156: To consider and act upon a resolution which would initiate an audit of the accounts of the Board of Education pursuant to Chapter II, Section 10(A) of the Charter of the Town of Trumbull. (Finance)
8. RESOLUTION TC30-157: To consider and act upon a resolution which would appropriate \$75,000 from the General Fund to 01010000-522202 Town Council-Services & Fees Professional. (Finance)
9. RESOLUTION TC30-158: To consider and act upon a resolution which would defer the implementation of the revaluation of real property required for the assessment year commencing October 1, 2025, until the assessment year commencing October 1, 2026. (L&A)
10. RESOLUTION TC30-138: RESOLUTION APPROPRIATING \$31,750,000 FOR THE PLANNING, DESIGN, DEMOLITION, CONSTRUCTION, RENOVATION, EQUIPPING AND FURNISHING OF A NEW SENIOR/COMMUNITY CENTER AND AUTHORIZING THE ISSUANCE OF \$31,750,000 BONDS OF THE TOWN TO MEET SAID APPROPRIATION AND PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE (L&A)
11. RESOLUTION TC30-139: To consider and act upon a resolution whereas the resolution entitled "Resolution Appropriating \$31,750,000 For The Planning, Design, Demolition, Construction, Renovation, Equipping And Furnishing Of A New Senior Center And Authorizing The Issuance Of \$31,750,000 Bonds Of The Town To Meet Said

Appropriation And Pending The Issuance Thereof The Making Of Temporary Borrowings For Such Purpose”, adopted by the Town Council on April 7, 2025, be submitted to the Town electors for approval or disapproval at a referendum to be held on Tuesday, June 17, 2025, between the hours of 6:00 a.m. and 8:00 p.m. (E.T.), and that the warning of said referendum shall state the question to be voted upon. (L&A)

12. RESOLUTION TC30-140: To consider and act upon a resolution which would direct the Town Clerk of Trumbull to prepare explanatory text for the Senior Center Referendum question, with the approval of the Town Attorney in consultation with the bond counsel and the Council Chairman. (L&A)
