NOTICE OF ADOPTION OF RESOLUTION

NOTICE IS HEREBY GIVEN that at a meeting of the Trumbull Town Council held on July 10, 2025, the following legislation was adopted:

1. RESOLUTION TC30-152: BE IT RESOLVED, That Vicki A. Tesoro, First Selectman, is hereby authorized to apply to the Connecticut Department of Transportation Microgrant Program for funding in the amount of \$5,000 for the purchase of eight bicycle racks and to sign all subsequent contracts, amendments, reports and related documents in order to administer and implement the project.
2. RESOLUTION TC30-153: BE IT RESOLVED, That Vicki A. Tesoro, First Selectman and Michael Lombardo, Chief of Police is hereby authorized to file an application to the Department of Justice, Community Oriented Policing Services, School Violence Prevention Program for funding to improve school safety and security, and to sign all subsequent contracts, amendments, reports and related documents to administer and implement the project.
3. RESOLUTION TC30-154: BE IT RESOLVED, That \$82,000 is hereby appropriated from the Fund Balance to 01030300-567702 Public Works/Fleet Maintenance-Vehicle Repair.
4. RESOLUTION TC30-155: BE IT RESOLVED, That the funding for a labor agreement between the Town of Trumbull and IAEP Local R1-604, SEIU, NAGE (EMTs and Paramedics) beginning July 1, 2024 and ending June 30, 2027 is hereby approved.
5. RESOLUTION TC30-156: BE IT RESOLVED, That the Town Council hereby initiates an audit of the accounts of the Board of Education pursuant to Chapter II, Section 10(A) of the Charter of the Town of Trumbull.
6. RESOLUTION TC30-157: BE IT RESOLVED, That \$75,000 is hereby appropriated from the General Fund to 01010000-522202 Town Council-Services & Fees Professional.
7. RESOLUTION TC30-158: BE IT RESOLVED That the Town of Trumbull hereby defers the implementation of the revaluation of real property required for the assessment year commencing October 1, 2025, until the assessment year commencing October 1, 2026.
8. RESOLUTION TC30-145: BE IT RESOLVED, That the appointment of Mary Isaac as a Town Council representative to the Trumbull Veterans & First Responders Center Building Committee, be and the same is hereby approved.
9. RESOLUTION TC30-151: BE IT RESOLVED, That Samantha Miller be and the same is hereby appointed as a member of the Equity, Diversity and Inclusion Task Force for a term extending to the first Monday of December 2028.

11. RESOLUTION TC30-139: BE IT RESOLVED, That the resolution entitled

DEMOLITION, CONSTRUCTION, RENOVATION, EQUIPPING AND FURNISHING
OF A NEW SENIOR/COMMUNITY CENTER AND AUTHORIZING THE ISSUANCE
OF \$27,115,000 BONDS OF THE TOWN TO MEET SAID APPROPRIATION AND
PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY
BORROWINGS FOR SUCH PURPOSE”, adopted by the Town Council on July 10, 2025,

state the question to be voted upon.
12. RESOLUTION TC30-140: BE IT RESOLVED, That the Town Clerk of Trumbull is
directed to prepare explanatory text for the Senior/Community Center Referendum
question, with the approval of the Town Attorney in consultation with the bond counsel and
the Council Chairman. The explanatory text shall include the Option 7 conceptual design
dated as of June 25, 2025 and the related tax impact study.
